**MINUTES June 24, 2015** 

### 1. CALL TO ORDER & ATTENDANCE

At 9:00 a.m., Commissioner Ainsworth declared the meeting of the Polk County Board of Commissioners to be in session. Commissioner Wheeler and Commissioner Pope were present.

#### 7. PUBLIC HEARING – ADOPTION OF THE 2015-2016 BUDGET – RESOLUTION #15-13

Greg Hansen, Administrative Officer, presented the budget for fiscal year 2015-2016 in the amount totaling \$58,967,525. The Budget Committee hearings occurred March 30 - April 2, and at that time a tentative budget was approved. The Committee met again on May 20 and formally approved the budget and set the general property tax rate, levy for paying off the road bond, and the Public Safety Operating Levy. Since that time, Mr. Hansen was able to reduce the operating levy proposed amount to \$.3048, based on the offset from the SRS funds received. There have also been minor changes to the budget, which resulted in a \$1,215,000 increase to the total County budget. These modifications include

- The General Fund beginning fund balance was increased by \$815,000 from SRS funding.
  \$25,000 of this was allocated to the CASA program, and the rest was put into contingency.
  Revenues from Drug Court were also reduced by \$120,000 in the Community Corrections fund.
- The Public Works beginning fund balance was increased by \$200,000. \$120,000 was appropriated to the Road Maintenance budget, and \$80,000 was appropriated to contingency.
- The Behavioral Health beginning fund balance was increased by \$200,000, which was then appropriated to contingency.

Chairman Ainsworth opened the meeting to Public Testimony.

E.M. Easterly, 775 Fir Gardens Ave., Salem, OR 97304, thanked the Board for their leadership, and commended the Commissioners and staff on their hard work in creating a readable and understandable budget that responds to the needs of the citizens in Polk County. Although only 1 in 10 eligible voters cast a ballot in the vote for the operating levy, the County made that process and the budget process open and available for public participation.

Hearing no further testimony, Chairman Ainsworth closed the public hearing.

MOTION: COMMISSIONER WHEELER MOVED, COMMISSIONER POPE SECONDED TO ADOPT RESOLUTION #15-13.
