MINUTES September 23, 2015

1. CALL TO ORDER & ATTENDANCE

At 9:00 a.m., Commissioner Ainsworth declared the meeting of the Polk County Board of Commissioners to be in session. Commissioner Wheeler and Commissioner Pope were present.

2. ANNOUNCEMENTS

Regular meetings of the Board of Commissioners are held on Tuesday and Wednesday each week. The Tuesday meeting is held in the Board of Commissioners' Office Conference Room, 850 Main Street, Dallas, Oregon. The Wednesday meeting is held in the Courthouse Conference Room, 850 Main Street, Dallas, Oregon. Each meeting begins at 9:00 a.m. and is conducted according to a prepared agenda that lists the principal subjects anticipated to be considered. Pursuant to ORS 192.640, the Board may consider and take action on subjects that are not listed on the agenda.

Department Head/staff meetings with the Board of Commissioners are held on Monday, Thursday, and Friday. The meetings are held in the Board of Commissioners' Office Conference Room and are conducted between 9:00 a.m. and 5:00 p.m. The principal subjects anticipated to be considered are on-going, upcoming, and new matters bearing on County operations. 3. COMMENTS (FOR ITEMS NOT ON THIS AGENDA)

Amanda Stephens, 1568 S 7th St., testified on behalf of the AFSCME Local 173 labor union. Ms. Stephens has worked for the County for two and a half years in the Developmental Disabilities department. She has three children and works two jobs to support her family. Over the course of her time here, Ms. Stephens and her colleagues have experienced an increased workload and higher job expectations due to Medicaid reform and additional monitoring requirements. While her workload and job requirements have gone up, Ms. Stephens's personal standards of living have gone down due to the County's "inadequate" cost of living increases. Ms. Stephens testified that although the County has \$3 million in increased funding, she feels "devalued and disrespected" by the County's final cost-of-living increase proposal. Ms. Stephens requested the Board reconsider their proposal and return to deliberations with the union with an "open mind" in an attempt to find a "fair and equitable resolution" that is respectable to the union and shows that the County.

Joseph West, 514 NE 80th Ave., Portland testified that he is the Council Representative for AFSCME. Mr. West presented a majority petition from the labor union requesting the Board return to the bargaining table and find a "reasonable settlement that they can feel positive about."
