Polk County Fairgrounds & Event Center Overnight Camping Rules Fair Office 503-623-3048/Caretaker 503-931-2013

- 1. \$20.00 for RV's and \$15.00 for tents per night includes electric and water at the pole, use of the dump station and restrooms with showers in them.
- RV fees must be paid the day of stay or in advance to Fair personnel. Office hours are Monday Friday 8:00am –4:00pm or see the caretaker at the front of the fairgrounds after hours. LATE FEES for nonpayment are \$20.00.
- 3. Polk County Fairgrounds use by Recreation Vehicles is solely for short term vacation use. Accordingly the length of stay are as follows:
 - * Self contained RV's limit is 14 consecutive days.
 - * Tents & RV's that are not self contained limit is 5 days.
 - * All vehicles staying in the RV lot must have current tags attached to the license plate or a current valid temporary permit.
 - * RV's must be in running condition and are subject to management decision
 - * Uninhabitable RV's must be removed, at owner's expense, from the Fairgrounds within 48 hours.
- 4. In addition to the specific rules outlined in this document, all individuals staying on the property must follow all Polk County Fair policies regarding conduct on Fair property.
- 5. Speed limit on the fairgrounds is **5 MPH** and strictly enforced.
- 6. Polk County Fair is not responsible for theft or damage incurred to vehicles parked on the fairgrounds.
- 7. All animals are not permitted to roam freely.
 - They must be either penned or on a leash at all times.
 - Persons having animals on the grounds must use every care to assure the safety of all visitors on the fairgrounds.
 - Anyone in violation of this policy will be asked to remove the animals from the grounds.
- 8. All sanitary needs for permitted animals will be the sole responsibility of the renter.
- 9. NO animals are allowed in the playground.
- 10. Washing of vehicles is prohibited.
- 11. No open fires.
- 12. Camping allowed in designated areas only.
- 13. Alcohol is permitted in camp sites only.
- 14. No roaming of grounds is allowed.
- 15. Dish/gray water and/or sewage cannot be expelled on the grounds. Valves and discharge ends to holding tanks must be closed and capped at all times unless there is an approved catch container attached. Discharging of holding tanks or leaking tanks are grounds for immediate removal of RV from Fairgrounds.
- 16. No construction, repairs, changing oil on RV's or vehicles on the fairgrounds
- 17. Do not disregard, deface, remove, tamper or damage any building, sign/notice posted or erected by the fairgrounds or other property of the fairgrounds.
- 18. Do not erect, replace, post or maintain any advertising matter, sign or printed material other than legal notices without prior approval by Fair management or Fair Board.
- 19. No soliciting, selling, offering for sale, peddling or vending of any food, liquids, goods, merchandise, services or any other items without approval of Fair management or Fair Board.
- 20. No discharging or possession of any loaded fire arm allowed.
- 21. No operating of radio, TV, or similar device so that it can be heard and disturb other campers.
- 22. Do not leave, deposit or scatter waste refuse or garbage.
- 23. Quite hours are 10:00pm 8:00am
- 24. Enforcement The Polk County Fair Board and Fairgrounds employees are authorized to enforce these rules.
