

POLK COUNTY FAIR CAMPING RULES

These rules have been put in place in accordance with **ORS 565.225** for safety purposes.

Failure to abide by these rules may result in immediate expulsion from the camp area, forfeiture of all fees paid and exclusion from the camping area during future Fairs. **Fair Management reserves the right to remove any camper/guest at their discretion. Broken rule policy: 1 verbal warning 1 written warning then removal from grounds by Security.**

General information

- **Camping application can be found on the Fair webpage and will need to be filled out correctly with proper signatures and either mailed in or brought into the Fair office by August 1st there will be no parking of any vehicle in the campground and no wristbands will be handed without paper work.**
- **Campsites are reserved for exhibitors with large animals first.**
- **Every exhibitor must sign along with a parent/guardian signature and all adults staying in the site must sign the Camping Rules Agreement before wristbands are handed out.**
- **Campsite need to be reserved and paid for online, no phone reservation will be made.**
- **Campsites come with 2 season passes, anyone else in your site that isn't an exhibitor must purchase a season pass before any wristbands are given for the campsite**

1. ALL CAMP SITE HOLDERS MUST CHECK IN WITH CAMP HOST BEFORE PARKING.

Campers, trailers & tents must be fully self-contained and have their camp pass displayed at all times. Must be in place by 8:00pm Tuesday August 8th. Set up days are **Noon** Sun. Aug. 4th – Tues. Aug. 6th 8:00pm

2. Campers & trailers may not extend in any manner into the designated fire lanes
3. Vehicles must be parked in camp area or in 4-H/FFA parent parking. Any vehicle parked in the fire lanes will be towed at the owners expense any vehicle not parked properly will be towed at the owner's expense.
4. NO stock trailers allowed in camp area, parking for stock trailers will be in the overflow parking field.
5. Absolutely NO drainage of waste water on the grounds. If found uncompliant you will be liable for all fines.
6. No Campfires
7. **Speed limit is 5 MPH in the camping area, parking area and roadway into Nesmith Park, violators will loose their ability to camp.**
8. Dogs and other pets are not allowed on the grounds or campsites.
9. All campers must wear a designated 'camping' wristband provided by the Polk County Fair office at all times while on the Fairgrounds or you will be asked to leave at curfew
10. Youth campers must have a chaperone age 21 or older stay all night in the campground, the chaperone must be registered with the fair office.
11. Curfew is at 11:00pm Thursday & Friday. Midnight on Saturday. Quite time is 11:00pm –7:00am daily.
12. No generators running after 11:00pm
13. Nesmith Park entrance will be opened to people with the appropriate passes.
14. You must clean up your camping area before leaving; **all garbage must be put in the big dumpsters at the fence line. Do not leave garbage in your camping area.**
15. No golf carts, ATV's or UTV's allowed in the camp ground unless given **written** permission by Fair management

The Polk County Fair Board has worked very hard with other County entities to continue the tradition and **privilege** of overnight parking for our 4-H/FFA exhibitors. Please help us keep this tradition alive for future 4-H/FFA exhibitors by obeying the rules that have been put in place for the safety of everyone on the fairgrounds.

NO CAMPSITE IS TO BE SET UP BEFORE NOON ON SUNDAY AUG. 4, 2024 and must check in with camping host before parking or you will lose the privilege to camp at the Polk County Fair.
