<b>Independence Paraphernalia</b>	Nicole Walker-Sundby reported she and Tanya Silva met with Chief Wells. Nicole stated Nancy Lodge of the Independence Downtown Association was going to an IDA meeting next Thursday to discuss the paraphernalia ordinance with the business community. Nicole reported they should know next Thursday if the ordinance will be accepted. Chief Wells will support Nicole and Tanya's efforts. Nicole stated that progress was a little slower than anticipated. West Salem is the next step, then the county. The county wants to see incorporated areas first, and then county will be responsible for non-incorporated areas.	<ul style="list-style-type: none"><li>Nicole and Tanya will attend the next Independence City Council Meeting.</li></ul>
<b>Ballot Measure 80</b>	Nicole stated there has not been much information from the state with regard to marijuana due to Ballot Measure 80. Sally Penna requested from the group a good source of information about the downside of marijuana use as she has not been able to find any. 	<p>Rita Grady from Polk CDC reported the state is currently going through the environmental review process for Firestone Place. She states she hopes if the weather is acceptable construction will begin in April. Rita reported the acquisition of a house on Church Street twill be used as grant funded alcohol and drug free housing. The Titus House is scheduled to move into the Church Street house by the end of the year. Rita stated that Marty Silbernagel had discussed the county purchasing a house for at-risk youth, but locating operational money would be challenging. Rita reported Polk CDC is not able to apply for any more funding until the next biennium. Nicole stated homeless youth at Morrison and Dallas have discussed the need for housing with their counselors.
