### 7. BCN REIMBURSEMENT

Morgan Smith reminded the Board that from June 29 thru November 2, Greg Hansen, Polk County Administrative Officer, also served as the Interim Co-Executive Director of the Mid Valley Behavioral Care Network (BCN). During this time, Greg tracked his time and mileage, and the County has received a check from BCN for reimbursement for these services. The check total is \$20,812.50. (\$1,012.50 for mileage and \$19,800 for time – 180 hours at \$110/hr.). In the past, when a Department Head as performed duties above and beyond their job description, they have received a stipend (though the County's only experience with this is inter-departmental, not with an external agency). The Board discussed a set amount per month, like a stipend, for the five months Greg served in this capacity.

BY CONSENSUS, THE BOARD ALLOCATED \$1,500 PER MONTH, \$7,500 TOTAL TO BE PAID TO GREG HANSEN, IN ADDITION TO TOTAL MILEAGE EXPENSES, OUT OF THE CHECK RECEIVED FROM THE BCN FOR HIS TIME SERVING AS THE INTERIM CO-EXECUTIVE DIRECTOR.

At 09:10 a.m., Commissioner Pope asked if there was a need for executive session. Staff answered that there was not and the meeting was adjourned.
