7. DELIBERATIONS - ZONE CHANGE 16-01

The Board deliberated on Zone Change 16-01, changing the existing zoning designation of a 5.2 acre property located at 9940 Hoffman Road, Monmouth, Oregon from Suburban Residential (SR) to Acreage Residential – Five Acre (AR-5).

Morgan Smith informed the Board that additional evidence has been submitted for this application, however the record is closed. If desired, the Board could re-open the record to allow this evidence to be submitted.

Commissioner Wheeler explained that she is puzzled why there is such an issue with swine manure, when every livestock animal is allowed in the SR zone and creates manure. The Evans' have raised swine for a number of years, and have been able to apply for and retain an agexempt building permit to house these animals. In addition, there has been no evidence of contamination to groundwater.

MOTION: COMMISSIONER POPE MOVED, COMMISSIONER AINSWORTH SECONDED, TO DENY THE APPLICATION FOR ZONE CHANGE ZC 16-01 AND DIRECTED STAFF TO CRAFT APPROPRIATE FINDINGS SUPPORTING A DENIAL.

MOTION PASSED 2-1 WITH COMMISSIONERS POPE AND AINSWORTH VOTING IN FAVOR, AND COMMISSIONER WHEELER VOTING IN OPPOSITION.

At 09:08 a.m., County Counsel announced that the meeting was recessed to Executive Session pursuant to 192.660(2)(d) to conduct deliberations with persons you have designated to carry on labor negotiations and 192.660(2)(h) to consult with your attorney regarding your legal rights and duties in regard to current litigation or litigation that is more likely than not to be filed. Although the public is excluded, no vote may be taken in executive session. Written minutes from the meeting are on file in the Board of Commissioners' office, but are confidential under ORS 192.660.

Commissioner Ainsworth called the meeting back into regular session.
