7. PUBLIC HEARING – WEST CLAY ST.

Commissioner Pope opened the public hearing.

Todd Whitaker, Public Works Director, presented the Engineer's Report and Certificate of Completion for the West Clay St. Cost Share Project. The road was completed in October, however there was road quality issues, so an additional 1.5 inch overlay was added, half the cost will be paid by the County for the additional structure, and half by the contractor. The original cost of the project was \$64,660 - \$48,495 was assessed for the cost share. The final

total was \$82,000. There will be no change in the assessment cost to the residents, the total cost for the county is \$48,411.

Bob Tucker, resident of Clay St., thanked the County for the road improvement, and got clarification of how and when the payments/assessments for the improvements would be due. Thad Boatwright, resident of Clay St., also thanked the County for the good job they did on the road, however, noted that he needs more rock on his father's driveway. Todd assured him that he will correct that. Thad also expressed concern that there is only one speed sign in the city limits portion of the road, and requested an additional speed sign on the County portion. Todd thinks the area will meet the criteria for residential speed, and if it does, no speed study will be required. It was also requested that a "Dead End" sign be added to any speed sign being installed.

Hearing no further testimony, Commissioner Pope closed the public hearing.
