7. PUBLIC HEARING

Austin McGuigan, Community Development Director, explained that the County has a Rural Renewal Energy Development Zone. This zone creates a 3-year tax abatement for new business developments (cap set at \$100 million). In the last ten years, two businesses (with a total of \$10 million development) have taken advantage of this tax abatement. This tax abatement expires this year, and at the Board of Commissioners meeting on April 10, the Board directed Austin to begin the process to apply for redesignation of this zone. All taxing districts were notified of the county's intent to reapply, and none have provided comment on this process.

Commissioner Ainsworth opened the public hearing. No members of the public were present. Commissioner Ainsworth closed the public hearing.
