MINUTES June 27, 2018

1. CALL TO ORDER & ATTENDANCE

At 9:02 a.m., Commissioner Ainsworth declared the meeting of the Polk County Board of Commissioners to be in session. Commissioner Pope and Commissioner Wheeler were present.

3. COMMENTS (FOR ITEMS NOT ON THIS AGENDA) — Polk County Citizen, Katherine Phillips, 4575 Morris Road, Dallas OR 97338, commented that a local company was spraying dust control chemicals on Smithfield Road near Meduri Cherry operations last Wednesday. Ms. Phillips claims the spray was puddled on the road, and it got all over her truck and trailer when she drove through it. She caught up with the driver that was spraying and he told her it was environmentally safe and easily washes off, however she claims it did not come off her wheel wells or her powder coated trailer deck. Ms. Phillips feels this looks bad on Polk County even though we were not the ones spraying. She believes it would help if Polk County started charging for the permits to spray these chemicals, and also if the home owner(s) hiring the dust control contractors had to fill out a "work within the right-of-way" permit. The Board agreed to look into this matter and there was no further discussion.

7. PUBLIC HEARING – ADOPTION OF THE 2018-2019 BUDGET – RESOLUTION NO. 18-12

Greg Hansen, Administrative officer, presented the budget for the fiscal year 2018-2019 in the amount totaling \$76,898,809. The Budget Committee hearings occurred April 3, 2018 to April 6, 2018, and at that time a tentative budget was approved. The Committee met again on May 16, 2018 and formally approved the budget and set the general property tax rate and the Public Safety Operating Levy. Since that time, Mr. Hansen has made minor changes to the budget, which resulted in a \$250,000 decrease in the total County budget appropriations. These modifications include:

- No net change in the General Fund.
- In Public Works there was an overall decrease of \$200,000 in funding associated with a decrease in Beginning Fund Balance. A corresponding decrease of \$200,000 to contingency.
- Decrease in the POINT Fund, Economic Development Fund, and Household Hazardous Waste Fund due to modifications to their Beginning Fund Balances.
- In the Behavioral Health Fund modifications were made to revenues resulting in no net change in the overall fund.

Commissioner Ainsworth opened the meeting to Public Testimony. Hearing no testimony, Commissioner Ainsworth closed the Public hearing.

MOTION: COMMISSIONER WHEELER MOVED, COMMISSIONER POPE SECONDED TO ADOPT RESOLUTION NO. 18-12.

MOTION PASSED UNANIMOUSLY.

At 09:28 a.m., Commissioner Ainsworth asked if there was a need for executive session. Staff answered that there was not and the meeting was adjourned.
