CITY OF KEIZER - MAYOR CATHY CLARK

Keizer Mayor Cathy Clark appeared with the Keizer Attorney Shannon Johnson, to request Polk County Board of Commissioners take legal action to prevent residents from discharging firearms on the property at or near 4000 River Bend Rd NW, Salem, Oregon. Keizer Attorney recaps the event that took place on June 2nd when a stray bullet entered a resident's home and landed a few feet away from the home owner. He goes on to recap the event from last fall where bullets had entered a nearby park and struck trees, which sent people running out of the park for fear of being shot. He stated he does not believe this was a negligent shooting but believes it is a matter of the

layout of the quarry which makes it impossible for people to know how close houses may be in any directions. Mr. Johnson stated he believes it is within the County's legal abilities to prohibit shooting from this property all together if it endangers the adjacent persons. He stated the City of Keizer if doing all it can but need the Polk County Board of Commissioners help to stop the shooting.

Keizer Mayor Cathy Clark stated she is also a resident of West Keizer and the residents are in distress. She stated there are laws that should be preventing bullets from being fired across the river, she also stated that because this is a recurring issue, she believes it has risen to the level that they, as leaders have a responsibility to take action to prevent gunfire from the property before there is an injury or fatality. She stated lives are at risk and it is not an acceptable situation.

At 9:22 a.m., County Counsel announced that the meeting recessed to Executive Session pursuant to 192.660(2)(f) To consider information or records that are exempt by law from public inspection. Although the public is excluded, no vote may be taken in executive session. Written minutes from the meeting are on file in the Board of Commissioners office, but are confidential under ORS 192.660.

Commissioner Ainsworth called the meeting back into regular session.
