#### 7. SEDCOR - Chad Freeman & Alex Paraskevas

Chad Freeman, SEDCOR President, informed the Board that Friday will be his last day with SEDCOR. He stated that he feels that SEDCOR is in a healthy place and have people doing business retention in the counties. He informed the Board that there are currently 2 candidates to replace him and he is confident that both choices would be a good option, and they should know within the next week who will be replacing him. Mr. Freeman also tanked the Board for their support over the years and their help in making Polk County great.

Alex Paraskevas, Polk County with SEDCOR, informed the Board that his work is primarily focused on Ag tech innovation. He helps counties get events together, and to bring people together that are interested in Ag tech. Mr. Paraskevas stated that he has worked with George Fox University to connect them with an Ag tech student for their Senior Engineer Program, and that student tis now building an broccoli harvester. He stated that he is working to help rural counties and rural cities move forward with Ag tech that you would normally see more of in bigger cities.

Commissioner Pope wants to know how much time is left on the Grant that is funding his position. He tell them he believes this grant ends December 31<sup>st</sup>, 2018, Mr. Freeman says they do plan to apply again when that time comes available, and he believes they should know when that will be in the next 30-60 days. He also stated that he feels the position and progress that has been made has been a key piece of moving forward and is confident they will receive the Grant at least for another year.
