#### 8. BNRG RENEABLES PILOT DISCUSSION

Ciaran Connelly is representing BNRG seeking payment in lieu of taxation. They are seeking the agreement to ensure certainty of what they will be paying in the future. Morgan Smith, County Counsel, stated that if the Board wants to move forward with an agreement he and Mr. Connelly will work together to prepare a Contract. Mr. Smith pointed out that in these agreements the developer can back out at any time but he doesn't foresee that being an issue.

Doug Schmidt, County Assessor, stated that he has never seen that happen and does not feel it would be in the best interest for the developer to do so because it could cause legislative issue. Mr. Schmidt stated that according to his calculations the County would receive more tax dollars with this agreement.
