#### 7. RESOLUTION NO. 18-15 – PUBLIC SAFETY LEVY

Greg Hansen, Administrative Officer, informs the Board that if they approve Resolution 18-15 in the matter of calling a Measure Election to submit a local option tax (public safety operating levy) measure to the voters of the County to re-authorize funding for public safety needs within Polk County, he will move forward with submitting it to the Clerk's office and proceed with getting a ballot title and getting it out on the election for May 2019. If it passes this levy will be no more than \$.425 with a duration of 5 years and the first year will eliminate the last year of the levy that was authorized in 2015.

MOTION: COMMISSIONER WHEELER MOVED, COMMISSIONER POPE SECONDED, TO APPROVE RESOLUTION NO. 18-15 IN THE MATTER OF CALLING A MEASURE ELECTION TO SUBMIT A LOCAL OPTION TAX MEASURE TO THE VOTERS OF THE COUNTY TO RE-AUTHORIZE FUNDING FOR PUBLIC SAFETY NEEDS WITHIN POLK CUONTY.
