SEDCOR AG BREAKFAST SPONSORSHIP – Alex Paraskevas, SEDCOR Representative, and Erik Andersson, President of SEDCOR, informed the Board that they would like to bring the annual Ag Breakfast to Polk County and are looking for sponsors to help that happen. They believe this will help bring the region together. Commissioner Pope stated that this is something he has wanted to see happen for a while now. There will be approximately 100 seats to fill and they will primarily be looking to fill those seats with people who are in the agricultural business. They have received financial support from other cities within the County and Commissioner Pope has suggested that if the Polk County Board of Commissioners could sponsor the breakfast also that SEDCOR could use those additional funds to help market the breakfast, and make sure those seats get filled. Erik Andersson stated that SEDCOR would continue looking for opportunities to have more meetings on this side of the bridge.
