7. TRANSPORTATION IN FALLS CITY

Brent DeMoe, Family Community Outreach Director, informed the Board that at a recent meeting regarding the funding for transportation in Falls City they were told that they would not be receiving the funding. He was told they had to worry about funding the existing projects before considering new ones. Mr. DeMoe stated that he did not feel that Polk County was given a fair chance to speak. He stated that they would not have given Polk County the opportunity to apply for this money if they were not considering new projects. Falls City Mayor, Jeremey Gordon, stated that he felt like they were pitting Polk County Services against each other by saying that if they funded the route to Falls City that they would have to cut another route in Polk County. Jessica Madronal, Community Engagement Coordinator, stated that she believes they are worried about future funding because of the emphasis they put on funding current programs before new projects. Mr. DeMoe is asking the Board if they are ok with him trying to appeal this decision that was made. Commissioner Pope stated that Polk County followed the process exactly the way they were asked and that he believes they should support the appeal. Commissioners Ainsworth and Mordhorst agree and staff is directed to move forward with appropriate appeal process.
