8. PUBLIC HEARING

Eric Berry, County Surveyor, is requesting the Board approve the vacation of various right of ways in Buena Vista. He informed the Board that back in the late 1800's when Buena Vista was platted they used much larger right of ways than Polk County requires today. Polk County started the process of correcting these right of ways back in 2000 and had mixed responses from residents in the area. They vacated the unnecessary right of ways where the residents approved and left the ones alone if the resident objected to the vacation. They did file a plan that the Board approved in 2002, that would allow them to go back and vacate these other right of ways in the future. Now they are seeking approval to correct more of the right of ways by making them smaller.

David Breeden, of 5790 Sequoia, Buena Vista testified in favor of the vacations by simply stating that he is in favor of the vacations.

Burney Shones, of 5731 Ferry Street, stated there is one section in the alley on his property where the power pole stands. He would like to leave that alone because the power company will need to maintain the power pole. Mr. Berry said that they reserve easements for any existing utility structures as part of the process. He will have to look at this pole specifically and figure out exactly where it is because he can't tell you without checking if it is the right of way, but he will look at that and find out. Mr. Shones would be in favor of the vacation as long as the utility company is still able to access the pole for maintenance.

Hearing no further testimony Commissioner Pope asked if there are any questions from the Board. Commissioner Ainsworth stated that he wants to make sure before they vote on this that the issues will be addressed going forward. Mr. Berry assured them that won't be a problem. Commissioner Pope closed the public Hearing.
