8. GENERAL LIABILITY/PROPERTY INSURANCE – FISCAL YEAR 2019-2020

Greg Hansen, Administrative Officer, explained that the County's general liability and property insurance policy ends of on June 30, 2019. Staff recommends purchasing General Liability in the amount of \$263,395.67, Automobile Liability/Physical Damage in the amount of \$60,967.69; Property/Boiler in the amount of \$83,957.54; Crime Coverage in the amount of \$1,721; and utilize the multi-line credit of \$30,624.04.

Ken Woods, Insurance Agent, gave a brief background of the County insurance and explained the proposed insurance coverage. Ken explained that the rates are up overall due to added coverage for mobile equipment, and increased claims in jails across the state.

9. WORKERS COMPENSATION INSURNACE – CARRIER SELECTION

Greg Hansen explained that the County's Workers Compensation Insurance ends on June 30, 2019. Staff recommends continuing the purchase Workers Compensation Insurance through CCIS in a 130% Retro Plan for fiscal year 2019-2020, which bases the premium on experience modifications.

Ken Woods gave a brief overview of the County's Workers Compensation claims, and explained the retro vs. standard policy and how experience modifications are calculated. For the upcoming year, the County's experience modification is .95. This rate is slowly going down after a string of higher than normal claim years.

COMMISSIONER AINSWORTH MOVED, COMMISSIONER POPE SECONDED, TO APPROVE THE STAFF RECOMMENDATION FOR THE PURCHASE OF WORKERS COMPENSATION INSURANCE THROUGH CCIS AS PRESENTED.

10. RESOLUTION 19-07 – ISSUANCE AND SALE OF FULL FAITH AND CREDIT OBLIGATIONS Greg Hansen presented Resolution No. 19-07, in the matter of authorizing the issuance and negotiated sale of full faith and credit obligations, series 2019; designating an authorized representative; authorizing the execution and delivery of a financing agreement and an escrow agreement; and related matters. Greg Hansen explained that these bonds will be used to fund identified needs in the County owned facilities. These projects include the construction of a new Emergency Operations Center and a remodel of the Public Works Facility. Greg is currently consulting with Cond Counsel on whether these bonds will be private sale (direct) or public sale.

11. RESOLUTION NO. 19-08 - YEAR END MODIFICATIONS TO 2018-2019 BUDGET

Greg presented Resolution No.19-08 in the matter of Increasing appropriations and Transferring Appropriations within multiple funds for fiscal year 2018-2019. Greg detailed the proposed modifications and explained that these year-end adjustments to the current budget are needed to prevent violating Oregon budget law.

MOTION PASSED BY UNANIMOUS VOTE OF THE QUORUM.

At 09:45 a.m., County Counsel announced that the meeting was recessed to Executive Session pursuant to 192.660(2)(E) to conduct deliberations with persons designated by the governing body to negotiate real property transactions, and 192.660(2)(H) to consult with counsel concerning the legal rights and duties of a public body with regard to current litigation or litigation likely to be filed.

Commissioner Pope called the meeting back into regular session. Staff was directed to proceed as discussed. The meeting was adjourned at 10:04 a.m.
