7. PERFORMANCE APPRAISALS

Matt Hawkins, Administrative Services Director, stated that the county has always had five categories in their overall rating on performance appraisals. He has received a request to change it to three categories. Instead of the existing five that are: outstanding, above average, satisfactory, needs improvement, and unsatisfactory; would be exceeds expectations, meet expectations, and needs improvement. Matt informed the Board that they had a time where everybody was being given above average when really they were just meeting expectations. Greg Hansen, Administrative Officer, explains that they have had only three categories in the past and it was found that supervisors were giving exceeds expectations when they were really just meeting expectation just to avoid any blow back from the employee. Matt requests that if we don't change the number of categories he would ask that he be able to reword the 5 categories to make it clearer. Morgan stated that he believes going to a three tier system rather than five will put an emphasis on the narrative of why they are in that category. If you have a bigger choice the supervisor will put more effort in figuring out which of the five options they get rather than choosing a score and writing more narrative to explain the score. Commissioner Pope would like Matt to work on the three categories, by discussing it with the department heads and seeing what they think about it.
