### 7. POLK CUONTY HISTORICAL SOCIETY

Rolfe Sterns, Treasurer for the Polk County Historical Society, informed the Board that pursuant to the lease agreement they have with the county they are required to get approval for any outdoor improvement to the property. They would like to have an outdoor exhibit area for

agriculture equipment fenced in with gates. As well as some sort of overhang to protect the artifacts from the weather. He is also requesting approval to put an 8ft X 10ft pre-fabricated shed up against one of the buildings. They have some donations lined up that will help get the fencing started. Commissioner Pope stated he is concerned with this creating long term planning issues. He pointed out that according to the hand out they was given to the Board the fence would be rendering a good portion of that property useless. He feels that if you are going to put up a fence that it should go all the way to the property line but the Master Gardeners shed is restricting use of the full property. Rolfe suggested extending the fence to the property line and giving the Master Gardeners a kay so they can access it when they need to. Commissioner Pope stated that he would like Public Works and County Surveyor Eric Berry to survey the property so determine exactly where the property lines are.

BY CONSESNSUS THE BOARD APPROVES THE IMPROVEMENTS PENDING THE PROPERTY SURVEY AND PLANNING BE INVOLVED.

#### 8. PROPERTY IN WEST SALEM

Matt Hawkins, Administrative Director, and Morgan Smith, County Counsel, informed the Board that there is a house in West Salem that was foreclosed on last fall and has several code enforcement issues. It is a 6 acre lot that has been abandoned and has a significant amount of garbage and decay, and the city of Salem has deemed it condemned. The city of Salem would like Polk County to accelerate the redemption period so we can take possession of it sooner. Morgan informed the Board that in order to do this they would have to declare that waste is occurring, and it could take approximately three months for that process to be completed.

BY CONSENSUS THE BOARD AGREED AND DIRECTED STAFF TO MOVE FORWARD WITH ACCELERATING THE REDEMPTION PERIOD.

At 09:52 a.m., Commissioner Pope asked if there was a need for executive session. Staff answered that there was not and the meeting was adjourned
