#### 7. VALLEY OF THE GIANTS PROPOSAL

Mayor of Falls City, Jeremy Gordon, City Manager, Mac Corthell & William Sullivan came to let the Board know of a project they would like to move forward with. Jeremy stated that they surveyed the people of Falls City to see what they wanted in the future for their town. The first was housing and the second was economic development. They want to enhance the existing assets and invite others to enjoy them. Increasing traffic to Valley of the Giants would help promote growth in Falls City. They are looking to engage Oregon Solutions who can take all the stakeholders to see if they can make it a viable recreation option in Polk County. They are in the process of trying to get a meeting with all the various stakeholders. They are asking the Board what their opinion of this project is and to ask for any feedback they might have. City Manager Mac Corthell stated that he feels like Falls City has more opportunity now than it has in the past and also that they are engaging the timber parties as well. They also have reached out to Salem Tourism Alliance and they agree that this is a unique place that Polk County has and would be a good addition to Polk County recreation. Commissioner Ainsworth stated that he believes the roads will be an issue depending on the weather and they will need a lot better signage. Commissioner Pope stated that he is a supporter of this project and he believes that Jeremy should make sure to stay involved in this process. He also stated that there is a long way to go and he believes BLM will be supportive but it is their responsibility to manage recreational needs. They are also responsible for cutting off access during high fire danger times. He suggests having a conversation with the Sheriff and discuss the new forest Deputy that will be patrolling and that could offset some of the issues with people violating safety measures. The mainline traffic management is also a concern. The log trucks are always on their CB radios so they know when they will encounter log trucks to avoid crashes and tourists won't do that. This is why Falls City should stay involved because they know the issues more than Travel Oregon. Commissioner Mordhorst suggests selling permits or doing guided tours for groups to limit access and give the timber companies reassurance that it will be a controlled number of people visiting. Mac Corthell said they will continue working on this and they will come back when they have some progress to report back on.

Commissioner Ainsworth called the meeting back into regular session and adjourned the meeting at 9:45 a.m.
