### 7. AUDITORS REPORT FOR FISCAL YEAR 2018-19

Linda Fox, Treasurer, introduced Brad Bingenheimer and Nicole Bourne, Auditors from the firm Boldt Carlisle & Smith and they will be presenting the June30, 2019 Audit for the Boards approval. Brad explained that this year the audit team was led by Nicole Bourne, and they have done what they call a modified report. They applied four different sets of auditing and each of these standards have a separate report. He continued by giving the Board financial highlights and stated the county had a slight decrease in net position. When looking at the five year history you can see a downward trend on the unrestricted net position, which is a continually growing deficit. One key factor relating to that is the net pension liability that the county has to report. Effective July 1 the county contribution rates jumped up a significant amount.

He also went over the various reports from the other auditing standards they applied. The first being the Oregon minimum standards report which addresses the county compliance with specific Oregon laws and regulations. There were a few different items that were over expenditures of appropriations for the year and the second publication of a public notice was missed. This report also looks at internal controls and they found the county's internal controls to be effective. The next set of standards is the government auditing standards which also looks internal controls as well as compliance with laws, regulations, etc. that effect financial statements, and they did not detect any instances of non-compliance. The final report is under the requirements of uniform guidance. This requires them to look at specific programs and determine if the county has internal controls to ensure compliance. They looked at the Women, Infant and Children as well as the Homeland Security Grant Program. Those results did not detect any weakness in the internal controls or instances of non-compliance.

8. AG BREAKFAST – Alex Paraskevas, SEDCOR Representative, and Eric Andersson, SEDCOR President, came to discuss the Ag Breakfast that is taking place in Polk County. Eric stated that last year was the first year they held an Ag Breakfast in Polk County. This year they are trying to focus on aftermath of the NORPAC issues. The wanted to focus on the growers who were impacted because the markets are questionable right now. Alex informed the Board that this year's topics are upcoming transfer growers and the consumer preferences and how that would impact what they should be growing. The Department of Agriculture will have a panel there; another topic will be hemp in Oregon; and there will be a Q & A with the audience. This event will be held at the Eola Viticulture Center on February 27<sup>th</sup>. They would welcome a table purchased by the county if the Board wishes, last year the Board sponsored a table and it was nice to have that visibility for the county. Commissioner Pope wants to know what the target number is for the Polk County event. Alex said last year was about 90 and this year they are hoping for 120-125.

9. PLANNING COMMITTEE VACANCY – Austin McGuigan, Community Development Director, is before the Board asking if they would like to reappoint Bill Farmer to the Planning Commission. His term ended at the end of 2019. He is also asking if he would like to continue having Michael Schilling as the Chair of that committee and Bill Farmer as Vice Chair which is how it stands now and staff recommendation. Both of them have already agreed to serve if reappointed.
