Brenda Young, of 2771 McPherson Road in Grand Ronde, stated that she had a complaint against her property and when a code enforcement officer spoke with her he said he could enter her property without a warrant. She emailed the Director of Planning, Austin McGuigan, as well as County Counsel, Morgan Smith to express her frustration. The code enforcement complaint was dismissed but she still feels that the code enforcement officer lied and said that interaction never happened. She has been trying to sell her property that is zoned as farm land but states she has had building approval in the past. She stated that re-zoning is a legal process and if it is denied it can then be appealed. She believes that the planning department has told potential buyers that there is no possible way to re-zone her property and that them doing so is legally inappropriate. She says that buyers have back out because they are told not to bother to apply because it will never be approved and that is not what she has been told in her communication with the planning department. She has been told that there is a process of applying and an option to appeal if denied. This issue has now cost her legal fees and she would like to give the Board the opportunity to deal with the problem or else she will sue the county.
