Commissioner Mordhorst did ask the Board if we would be able to modify our Business Development grant to be able to help some of the local businesses through this time. Commissioner Pope and Ainsworth responded by reminding him that the recent order the Board adopted to waive the restaurant licensing fees will be covered by the same fund as that grant so this fiscal year that fund is exhausted. They also stated that anyone can apply for that grant and it is designed to create and or save jobs so they don't believe they would need to modify it.
