Commissioner Pope stated that the Board received an email from Association of Oregon Counties (AOC) with a letter from the Governor's office asking counties to be collaborative with regard to the \$200 million that could be distributed to the counties and cities from the CARES Act dollars. Oregon received a total of \$1.635 billion from the CARES relief fund dollars and 45% of that money was supposed to be made available to local governments and the Governor's office has not dispersed the funding. Commissioner Pope plans to contact the state representatives and reiterate that the money was not intended to be held by the state and that Polk County need these dollars to be appropriated back to the counties for the businesses because that is what it was intended to be used for.
