PUBLIC HEARING - COMMUNITY DEVELOPMENT

Austin McGuigan, Community Development Director, informed the Board that the Dallas, Monmouth, Independence enterprise zone II is going to expire July 1, 2020 and Polk County is a co-sponsor of the enterprise zone, which is a special taxing economic development incentive that is offered by Business Oregon. There is an application process and Business Oregon has to approve the application. The enterprise zone in our area started in Dallas in 1987 and we have consistently had some version of that since then. Dallas wants to submit an application for a renewal of the existing enterprise zone and is asking Polk County to be a sponsor again. Oregon state law does not require

a public hearing for the matter but Austin does recommend it to take any comments by anybody who might want to comment. Commissioner Ainsworth asked if there was any public testimony and there was not. Commissioner Pope asked who the managing agent would be. Austin said it would be the Dallas City Manager or their designee.
