7. PUBLIC HEARING - ADOPTION OF THE 2020-2021 BUDGET - RESOLUTION NO. 20-07

Commissioner Ainsworth opened the public hearing. Greg Hansen, Administrative Officer, stated that the hearing was for the adoption of the 2020-2021 budget and that it will be effective on July 1, 2020. In April 2020 we had budget hearings and then on May 20, 2020 the budget was formally approved and the property tax rate and the levy rate for the public safety levy were set. Property tax rate was set at 1.716 and the public safety levy was set at 42.5 cents. In the Boards packet there are the recommended changes to the budget that was formally approved. Most of these changes are

minor adjustments to the beginning fund balance. Public Works has a \$300,000 increase as a result of some paving projects that were planned to be done before the end of this fiscal year and will not be done until next fiscal year. There is a \$500,000 reduction in the construction fund at Public Works. Mr. Hansen reviewed the rest of the adjustments listed in the packet including the Fair fund modification. The Fair Fund modification is the biggest modification because they were not able to hold the normal county fair. There is a \$24,000 reduction in the year round operations and \$106,000 reduction in the annual county fair. The next step is to approve Resolution No. 20-07 to adopt the budget of \$87,296,051 as well as the programs in the General Fund and the other funds that are identified in their total amount. Also in this Resolution is the property tax rate set at 1.716 and the 42.5 cents for the public safety levy.

Commissioner Ainsworth asked if there was any public testimony, there was none and he closed the public hearing.

Morgan Smith, County Counsel, informed the Board the he got more clarification on the face covering guidelines from the state. His interpretation of the guidance is that Polk County is on responsible for enforcement to establishments that the county provides a permit or license too. The state has encouraged counties to extend enforcement to other establishments as well but have given the counties an opportunity to pass that enforcement to the state. If counties was to defer that responsibility they will need to let Oregon Health Authority know so that they can triage any complaints accordingly. Mr. Smith asked for direction from the Board as to what they would like him to do.

BY CONSENSUS THE BOARD AGREES TO DEFER THE ENFORCEMENT OF FACE COVERINGS TO THE STATE, FOR ESTABLISHMENTS THE COUNTY DOES NOT PROVIDE A LICENSE.
