Fire Chief Fred Hertel, with Sheridan & SW Polk Fire Districts attended the meeting to update that Board on the effects of recent flooding and yesterday's snow event. Chief Hertel stated that there were 34 calls yesterday of various nature all relating to the snow fall yesterday afternoon. There was an accident that occurred on Highway 22 and Oak Grove Road that required 4 ambulances and there were 9 patients in total.

The flooding that Polk County experienced a few weeks ago caused significant damage to the access points at the Salt Creek Station and Chief Hertel indicated that he may be discussing funding options with Public Works for the repairs needed.

The Commissioners and Chief Hertel discussed the protocol for response in the event of a rescue need and the agencies that would be the primary response team for various situations. SW Polk is the primary rescue response for the entire stretch of Highway 22 in Polk County. Once the Salt Creek Station is up and running it will double their capacity for responders. They are currently recruiting for more volunteers and will be sending out a mailer to everybody in SW Polk County soon.
