# 8. ECONOMIC DEVELOPMENT APPLICATION DISCUSSION

The Board discussed the application they received from Andreas Wetzel, owner of Chateau Bianca Vineyards to help him a project that would bring phase 3 power to his Winery. This would allow him to use his equipment in a more efficient way. This would give him the ability to crush and bottle grapes from many other local vineyards. Commissioner Pope stated that he believes there may be other avenues Mr. Wetzel can seek for additional funding for his project and that he asked Business Oregon and SEDCOR if they have had a chance to respond to Mr. Wetzel's inquiry about help with funding. Mr. Wetzel has not heard back from them but Craig will assist him in making that connection. The Board agreed that it will support the local economy and also that there will be others who benefit from this phase 3 power being brought to that area. The Board agreed that they would be willing to support him for up to \$20,000. This would be paid on a reimbursement basis.
