### 7. PLANNING COMMISSION APPLICANT INTERVIEW

Timothy (Tim) Klarr from West Salem submitted an application to serve on the Planning Commission. Commissioner Gordon asked Mr. Klarr to briefly describe his understanding of the land use process. Ms. Klarr answered that his knowledge is limited at this point but would do the research and use his resources to understand the laws the applied to any case he was presented with. Commissioner Mordhorst asked Mr. Klarr what he considers the most important land use issues Polk County is facing over the next four years. Mr. Klarr believes that infrastructure for growth is the most important land use issue Polk County faces. Commissioner Pope asked Mr. Klarr what he would do to make statewide land use planning better. Mr. Klarr responded that he doesn't feel that he knows the details of the statewide land use program well enough to say what should be changed. He hopes that is he is able to serve on the Polk County Planning Commission he will learn a lot and make sure to do his research. Commissioner Gordon asked Mr. Klarr

how he would react if the Board overturn a recommendation that was made by the Planning Commission. Mr. Klarr stated that he recognizes that the Planning Commission is an advisory Committee and also that the Board of Commissioners are the ones who have to make the decisions and they are the ones who will have to answer to the public for whatever the decision is that they make.

Mr. Klarr asked if he is appointed to the position are there restrictions for who he can discuss certain land use matters with. Morgan Smith, County Counsel advised Mr. Klarr that yes there would be in some cases. It is best practice for any discussion about a land use case be done at the land use meetings and or hearings.
