FAILURE TO RAISE AN ISSUE IN THIS HEARING, IN PERSON OR BY LETTER, OR FAILURE TO PROVIDE ADEQUATE SPECIFICITY TO AFFORD THE BOARD AN OPPORTUNITY TO RESPOND TO THE ISSUE MAY PRECLUDE LATER APPEAL TO LUBA ON THAT ISSUE.
  - a. Individuals in favor of the application or appeal.
  - b. Individuals against the application or appeal. At the discretion of the Chairman, an attorney, consultant, or other designated representative of two or more individuals may be allowed the combined time for each represented individual who does not speak, not to exceed 20 minutes. The Chairman may require proof of designation.
- 5. Rebuttal by Applicant (Appellant) (10-minute limit).
- 6. Questions from Board (discussion limited to individuals questioned by the Board).

#### 7. PUBLIC SAFETY LEVY RE-AUTHORIZATION:

Greg Hansen, Administrative Officer, provided his recommendation to the Board as follows:

- To place a Local Option Tax (operating Levy) measure on the ballot for May 16, 2023, general election to re-authorize the 2019 public safety levy in Polk County.
- A local option tax (operating levy) in an amount not to exceed \$0.495/\$1,000 assessed value for the duration of five (5) years.
- As part of the measure, the county would eliminate the final year of the 2019 voter approved public safety operating levy

Mr. Hansen's memorandum provided some background information regarding the public safety levy, as well as, some answers to questions that may be asked, what the alternatives may be, and fiscal impacts. Mr. Hansen stated for the record that the Sheriff is not in attendance because he is currently attending a conference and it is not due to lack of support. DA Aaron Felton is also not in attendance due to a personal reason, and not because of lack of support, and Commissioner Pope had an appointment that he could not miss, but he spoke with Mr. Hansen yesterday and shared his support for the recommendation. Mr. Hansen stated for the record that this is not a final decision, this is the starting point to be able to open up the public hearing and final Board Order. Commissioner Gordon stated that he knows the increase is a lot to ask of people but he understands the need for this and he supports the recommendation. Commissioner Mordhorst would like to schedule a public outreach and that he supports the recommendation.
