SUBJECT: NON-REPRESENTED PAY & BENEFITS

The cost of living increase/benefits for non-represented employees for 2023-2024 are as follows:

1. The cost-of-living adjustment for the fiscal year is 4.0% effective July 1, 2023.

Health benefits will be paid 90% by the County and 10% by the employee. Employees opting out of County health insurance coverage shall receive \$300.00/month. One insurance provider had a major increase Kaiser (9.0%) and PacificSource had a small increase (1.0%) this upcoming year.

 Personal leave days for non-represented employees shall remain at five (5) personal leave days. These days (used in full day increments) must be used during the course of the fiscal year and shall not be carried over for future use.

RECOMMENDATION/DISCUSSION:

It is time to determine the Non-Represented COLA for the upcoming fiscal year. My recommendation is 4.0% based upon the following:

 DSA and FOPPO
 - 3.0% July 1, 2023 and 2.0% on January 1, 2024

 Deputy DA
 - 4.0% July 1, 2023

 AFSCME - General
 - 3.0% July 1, 2023

 AFSCME - BH
 - 1.5% plus a step

Also, AFSCME received numerous salary adjustment increases over the past year.

INTERGOVERNMENTAL AGREEMENT Between POLK COUNTY, OREGON and the ORS 190 ENTITY, MID-WILLAMETTE VALLEY HOMELESS ALLIANCE

1. PARTIES TO AGREEMENT

This Agreement is between Polk County, a political subdivision of the state of Oregon, ("Polk") and the ORS 190 Entity, Mid-Willamette Valley Homeless Alliance ("ORS 190 Entity"), and this agreement is made pursuant to ORS Chapter 190.

2. PURPOSE/STATEMENT OF WORK

The purpose of this Agreement is to establish the terms and conditions under which the Polk will provide financial and budgetary services to the ORS 190 Entity. These services are further described in Exhibit A which is hereby incorporated into this agreement.

3. TERM AND TERMINATION

3.1 This Agreement shall be effective for the period commencing upon all signatures and ending on June 30, 2024 unless terminated or extended as provided herein.

3.2 This Agreement may be extended by agreement of the parties. Any modifications in the terms of such amendment shall be in writing.

3.3 This agreement may be terminated by mutual consent of both parties at any time or by either party upon 30 days' notice in writing, and delivered by mail or in person. Any such termination of this agreement shall be without prejudice to any obligations or liabilities of either party already accrued prior to such termination.

4. OBLIGATIONS UNDER THE TERMS OF THIS AGREEMENT

4.1 Under the terms of this agreement, the parties shall designate a central point of contact for all communications required to effectuate the services and support contemplated under this agreement.

4.2 Polk shall perform the tasks assigned to it in Exhibit A for the ORS 190 Entity for an amount of \$8,500 per month.

4.3 The ORS 190 Entity shall perform the tasks assigned to it in Exhibit A for Polk in consideration for the services provided by Polk.

4.4 At all times under this agreement, individuals either employed or volunteering at Polk to perform services under this agreement shall be agents of Polk. No individual at Polk performing services under this agreement shall be considered an employee or agent of the

ORS 190 Entity nor shall they be entitled to any rights and/or benefits conferred to ORS 190 Entity employees.

5. COMPLIANCE WITH APPLICABLE LAWS

The parties agree that both shall comply with all federal, state, and local laws, ordinances, and Contracts from the State of Oregon applicable to the work to be done under this agreement. The parties agree that this agreement shall be administered and construed under the laws of the state of Oregon.

6. HOLD HARMLESS

To the extent permitted by Article XI, Section 7 of the Oregon Constitution and by the Oregon Tort Claims Act, each party agrees to waive, forgive, and acquit any and all claims it may otherwise have against the other and the officers, employees, and agents of the other, for or resulting from damage or loss, provided that this discharge and waiver shall not apply to claims by one party against any officer, employee, or agent of the other arising from such person's malfeasance in office, willful or wanton neglect of duty, or actions outside the course and scope of his or her official duties. For any and all claims against either Polk or the ORS 190 Entity from a third party, each party agrees to defend and indemnify each other for any and all claims arising from the actions of their employees and/or agents.

7. INSURANCE AND RISK MANAGEMENT

Each party shall insure or selfinsure and be independently responsible for the risk of its own liability for claims within the scope of the Oregon tort claims act (ORS 30.260 TO 30.300).

8. MERGER CLAUSE

Parties concur and agree that this agreement constitutes the entire agreement between the parties. No waiver, consent, modification or change to the terms of this agreement shall bind either party unless in writing and signed by both parties. There are no understandings, agreements, or representations, oral or written, not specified herein regarding this agreement. Parties, by the signatures below of their authorized representatives, hereby agree to be bound by its terms and conditions.

9. NOTICES

Any notice required to be given the Polk or the ORS 190 Entity under this Agreement shall be sufficient if given, in writing, by first class mail or in person as follows:

EXHIBIT A SCOPE OF WORK RESPONDING TO THE GOVERNOR'S EXECUTIVE ORDER 23-02

INTERGOVERNMENTAL AGREEMENT BETWEEN POLK COUNTY AND THE ORS 190 ENTITY, MID-WILLAMETTE VALLEY HOMELESS ALLIANCE

Polk County shall undertake the following items in support of the ORS 190 Entity, Mid-Willamette Valley Homeless Alliance under this Agreement:

- 1. Maintain copies of local provider contracts and other contracts for goods and services supported by funds provided under the Governor's Executive Order 23-02.
- 2. Re-verify that local provider contracts meet contract paperwork requirements.
- 3. Track expenditures submitted by each local provider and authorize the Mid-Willamette Valley Council of Governments (COG) to make payments.
- 4. Review COG financial reports with grant tracking records.
- 5. Compile information, upon request, for reporting purposes; e.g., to the State of Oregon, auditors, and COG.

The ORS 190 Entity, Mid-Willamette Valley Homeless Alliance, shall undertake the following in support of Polk County's work under this agreement:

- 1. Verify that local provider contracts have completed paperwork; e.g., insurance certificates, signatures, exhibits, prior to authorizing payment for services.
- 2. Provide Polk County with monthly reports by the 10th day following month close, including but not limited to two bank reconciliations and revenue and expenditure reports.
- 3. Maintain financial records and documentation by provider and allowable expense categories.
- 4. Hire or retain by contract sufficient staff or contractors to perform the ORS 190 Entity's responsibilities under this agreement.
