1. At 9:00 a.m., Commissioner Pope declared the Tuesday meeting of the Polk County Board of Commissioners in session and led the Board and attending audience in the Pledge of Allegiance. Commissioner Gordon and Commissioner Mordhorst were present.

## 3. MINUTES: COMMISSIONER MORDHORST MOVED, COMMISSIONER GORDON SECONDED TO APPROVE THE MINUTES OF February 20, 2024

## 4. COMMUNITY CORRECTIONS UPDATE:

Jodi Merritt, Community Corrections Director, provided a department update to the Board. Mrs. Merritt's began her update with the juvenile department where she discussed the current staffing levels and stated that their numbers are finally at pre-pandemic levels. Next, Mrs. Merritt talked about Corrections for adults and she also shared some data and talked about their staffing levels. Mrs. Merritt also highlighted a funding opportunity they are hoping to receive in this current legislative session. Commissioner Mordhorst asked Mrs. Merritt to clarify what the three main acronyms she used are and Mrs. Merritt answered his question. Mrs. Merritt also shared some challenges that they are running into with the changes that are being made to the contact standards. Commissioner Mordhorst asked if the Judges or DAs are able to provide input on this current legislative session and Mrs. Merritt stated that she believes that they will be able to provide public comment but she cannot answer that question further. Commissioner Gordon wanted to recognize Mrs. Merritt for all of her hard and incredible work. Mrs. Merritt spoke about HB4002 in regards to the Measure 110 reform and discussed what they are doing in order to prepare for these possible changes. Commissioner Mordhorst thanked Mrs. Merritt for going above and beyond in her role. Commissioner Pope weighed in on the current short session and stated that he doesn't feel that HB4002 is appropriate for a short session.

## 5. MORRIS ROAD VACATION PUBLIC HEARING DATE SETTING:

Morgan Smith, County Counsel, stated that the Board needs to set a date on the record for a public hearing to discuss the remaining road vacation for Morris Road. Mr. Smith provided some background information on what this is regarding and what the process will look like from Public Works once a date is set. Mr. Smith recommends having the public hearing on April 3, 2024.

## What Is FACT?

Forensic Assertive Community Treatment (FACT) is an evidenced based intervention method intended for individuals with serious mental illness (SMI) who are involved with the criminal justice system.

FACT addresses criminogenic risks and complex needs, which are factors in an individual's life directly related to re-offending. In this sense, FACT is an intervention that bridges behavioral health and criminal justice systems.

The goals of FACT are to:

- Improve the individuals mental health outcomes and daily functioning;
- Reduce recidivism by addressing criminogenic Risks and needs;
- Divert individuals in need of treatment away from the criminal justice system;
- Manage costs by reducing reoccurring arrest, incarceration, and hospitalization; and increase public safety.


## Who is Eligible?

Criteria for eligibility to FACT services includes criteria such as:

- Severe Mental IIIness
- Significant Functional Impairments
- Indicators of continuous high service needs
- Medium to high criminogenic risk and needs.
- Current or recent involvement with the criminal justice system, including a history of failure to comply with criminal justice system supervision.


## Team Make-Up

FACT provides services that are client-focused, community-based, time-unlimited, and delivered by a multidisciplinary team.

- Mental Health Counselor
- Case Manager
- SUD Counselor
- Peer Support
- Supported Employment
- Probation Officer
- Prescriber
- Nurse


## Community Corrections Partnership

- Specialized CIT trained PO
- Provide program referrals
- Participation in Collaborative Staffing meetings
- Collaborative Case Planning by criminogenic needs
- Prioritizes livability issues/concerns and mental health
- Client engagement and rapport
- Supervision strategy balances needs of the participant and public safety


## Services Provided

- Mental Health and SUD Therapeutic Interventions including skill development that address criminogenic risk and needs.
- Coordination with criminal justice entities
- 24/7 Support via ACT Phone to help manage symptoms and other needs
- Advocacy and assistance navigating the criminal justice system
- Application assistance with enrollment in social entitlements or benefits.
- Medication education and management
- Support with navigating resources and systems to secure and/or maintain supportive housing
- Skill development in activities of daily living
- Supported Employment Services
- Opportunities to participate in pro-social activities and interpersonal skill development
