#### **6. GIS DEPARTMENT UPDATE**

Eric McAvoy, GIS Manager, provided a department update to the Board and went over a prepared slideshow. Mr. McAvoy's update went over the staff in his department and who they provide GIS services for in and outside of Polk County. Next, he talked about PSMAPS 5, the usage since 2021 and he explained that the program is reaching its end of life. The slideshow went over a timeline of PCMAPS starting in 1993 and they are anticipating it to stop working in June 2025. Mr. McAvoy stated that the new program they are working on right now is called KLOP, which is rolling out on December 30th, 2024, with an estimated lifespan of 10 years. He explained that it is much more mobile device friendly, uses the same data, it is more secure, and there are no new costs for the program. Mr. McAvoy then talked about Assessor's Cartography for ArcGIS Pro and the work that has been done in that department and working with that program. Other projects they are working on include zoning updates, ambulance service areas, KLOP and the planning research tool. Commissioner Pope asked what does KLOP stand for and Mr. McAvoy stated that it is POLK backwards. Commissioner Gordon asked if they would be able to create some kind of demonstration for the public and Mr. McAvoy stated that yes, they plan to.

This assessment is integral in submitting the city's project for statewide funding. As part of the most recent Water Master Plan, the Dayton Street Water-Wastewater-Pedestrian Bridge was identified as a vital component of the city's ability to provide water/wastewater service to the south side of town, as well as being a daily use pedestrian bridge. The project is estimated at approximately \$500,000~1,200,000 depending on whether repair or replacement will take place. ## AMENDMENT TO OREGON HEALTH AUTHORITY 2023-2025 INTERGOVERNMENTAL AGREEMENT FOR THE FINANCING OF PUBLIC HEALTH SERVICES

This Fourteenth Amendment (this "Amendment") to Oregon Health Authority 2023-2025 Intergovernmental Agreement for the Financing of Public Health Services, effective July 1, 2023, (as amended, the "Agreement"), is between the State of Oregon acting by and through its Oregon Health Authority ("OHA") and Polk County, ("LPHA"), the entity designated, pursuant to ORS 431.003, as the Local Public Health Authority for Polk County. OHA and LPHA are each a "Party" and together the "Parties" to the Agreement.

#### **RECITALS**

WHEREAS, OHA and LPHA wish to modify the Fiscal Year 2024 (FY24) Financial Assistance Award set forth in Exhibit C of the Agreement.

WHEREAS, OHA and LPHA wish to modify the Exhibit J information required by 2 CFR Subtitle B with guidance at 2 CFR Part 200 (FY24);

WHEREAS, OHA and LPHA wish to modify the Fiscal Year 2025 (FY25) Financial Assistance Award set forth in Exhibit C of the Agreement.

WHEREAS, OHA and LPHA wish to modify the Exhibit J information required by 2 CFR Subtitle B with guidance at 2 CFR Part 200 (FY25);

#### **AGREEMENT**

NOW, THEREFORE, in consideration of the premises, covenants and agreements contained herein and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties hereto agree as follows:

- 1. This Amendment is effective on **November 1, 2024**, regardless of the date this amendment has been fully executed with signatures by every Party and when required, approved by the Department of Justice. However, payments may not be disbursed until the Amendment is fully executed.
- **2.** The Agreement is hereby amended as follows:
  - **a.** Exhibit C, Section 1 of the Agreement, entitled "Financial Assistance Award" for FY24 is hereby deleted and replaced in its entirety by Attachment A, entitled "Financial Assistance Award (FY24)", attached hereto and incorporated herein by this reference. Attachment A must be read in conjunction with Section 3 of Exhibit C.
  - **b.** Exhibit J of the Agreement entitled "Information required by 2 CFR Subtitle B with guidance at 2 CFR Part 200" (FY24) is amended to add to the federal award information datasheet as set forth in Attachment B, attached hereto and incorporated herein by this reference.
  - c. Exhibit C, Section 1 of the Agreement, entitled "Financial Assistance Award" for FY25 is hereby deleted and replaced in its entirety by Attachment C, entitled "Financial Assistance Award (FY25)", attached hereto and incorporated herein by this reference. Attachment C must be read in conjunction with Section 3 of Exhibit C.

- 3. LPHA represents and warrants to OHA that the representations and warranties of LPHA set forth in Section 4 of Exhibit F of the Agreement are true and correct on the date hereof with the same effect as if made on the date hereof.
- 4. Capitalized words and phrases used but not defined herein shall have the meanings ascribed thereto in the Agreement.
- **5.** Except as amended hereby, all terms and conditions of the Agreement remain in full force and effect.
- 6. This Amendment may be executed in any number of counterparts, all of which when taken together shall constitute one agreement binding on all parties, notwithstanding that all parties are not signatories to the same counterpart. Each copy of this Amendment so executed shall constitute an original.
