I am writing on behalf of the OSU North Willamette Research and Extension Center (NWREC) in Aurora to express our sincere gratitude for the ongoing support Polk County has provided over the years to foster agricultural economic development for its residents. Our programs cover a wide range of areas, including fruit trees, nursery management, integrated pest management (IPM), agrivoltaics, berry crops, IR-4 pesticide research, small farms, plant pathology, Christmas trees, and vegetable crops. At NWREC, we are not just responding to challenges—we are driving progress, pioneering solutions, and shaping the future of agriculture in the Willamette Valley. We also have robust programs for youth who want to learn about farming and become farmers in the future. I would be pleased to present some of the cutting-edge research and Extension highlights of these programs during the Extension annual budget meeting with the commissioners.

We are very grateful for the financial support Polk County offered in fiscal year 2024-2025 of \$20,000, up from \$12,000 in fiscal year 2023-2024 — thank you. We really appreciate the trust you have put in us with this increased funding, knowing you have competing priorities in your county. We are continually faced with increased costs for conducting research, and for FY25-26, we are requesting our commissioners for financial support of \$23,000 from Polk County Economic Development to support NWREC in meeting our expanded research, outreach, and educational initiatives. This level of funding is 3% more than our request last year which was \$22,200.
