1. At 9:00 a.m., Commissioner Pope declared the Tuesday meeting of the Polk County Board of Commissioners in session and led the Board and attending audience in the Pledge of Allegiance. Commissioner Gordon and Commissioner Mordhorst were present.

5. POLK COUNTY SHERIFF UPDATE

Mark Garton, Polk County Sheriff, provided a department update to the Board. Sheriff Garton's update went over an activity summary from May 7th through July 8th, 2025 and he went over some "noteworthy" incidents. Sheriff Garton also went over crime & investigations, traffic safety & enforcement, arrests & agency assists, and he shared data from call and traffic stop totals. Sheriff Garton talked about their current staffing levels in his office and for the jail. He talked about some changes in Marine Patrol but he doesn't have much information as of now. Sheriff Garton gave a small preview of National Night Out, which is happening soon and he updated the Board on where they are at with the dog kennel. Sheriff Garton also shared a handout that went over an operational snapshot of the last two months. Commissioner Mordhorst thanked him and his team for all their hard work and asked him to elaborate on more on the numbers of citations and Sheriff Garton answered his question. Commissioner Gordon also thanked him for his work and asked him to talk a little more about the struggles happening with the marine boards funding. Sheriff Garton answered his question. Commissioner Pope shared his concerns with the marine board and applauds the fact that the Sheriff's Office is involved with them as much as he is. Commissioner Pope asked the Sheriff to elaborate more on the data he shared about inmates in the jail.

6. PROPOSED SPEED ZONE ON SOUTH OAK GROVE RD.

Todd Whitaker, Public Works Director, stated that he was here today to talk to the Board about a proposed speed zone request on South Oak Grove Road. Mr. Whitaker stated that there was a traffic pattern change that occurred on HWY 22 and 51 which is increasing traffic on South Oak Grove Road and due to complaints from local residents, ODOT reached out to Public Works asking if they would want to implement a speed zone of 25 mph.








Polk County AV






Polk County AV - % change

Exemptions

- Enterprise Zone Update 3 active
 - West Salem Machinery
 - \$29,700 (2023 and 2024 taxes).
 - New assets for 2025.
 - Ascentec Engineering
 - \$358,843 (2023 and 2024 taxes) When taxable will go to Urban Renewal.
 - New assets for 2025.
 - OpenRoad Global
 - \$43,000 (2024 CIP Enterprize Zone taxes).
 - First year exemption for 2025.

Exemptions

Community Solar ORS 307.175(5)

These solar farms are taxable while under construction. Once they have completed their local governmental electrical inspection prior to starting operations, they are granted exemption. We have two solar farms that were taxed while under construction, and are now exempt. Both solar farms are in TCA 4408. Districts affected are West Valley RFPD, Willamina School District, CCC, Polk Soil & Water, and Polk County.

\$57,000 in taxes removed from the roll in 2024-25.

\$80,000 in taxes removed from the roll for this year 2025-26.

- 6 Community Solar farms
- 3 upcoming Community Solar farms (unknown if taxable while under construction)
- 3 taxable Solar Farms
 - 1 with no exemption (2024-25 taxes \$14,837.76)
 - 2 PILT agreements (\$15,400)

Legislative Update

SB 1094 – Veteran's exemption/tax credit

- Work started in the 2024 short session; hoping for a solution in 2025. Now working towards a solution in 2026.
- Chair Meek sponsored SB 1094. The bill got hung up for a couple months with LRO doing the math on the exemption amounts. We don't know why it took so long? After prodding, it passed the Senate 30-0.
- Died in the House as a result of collateral damage.
- We had time to get it heard in the House, but word was that the democratic leadership were holding up a bunch of bills as leverage to get Chair Meek to vote for the transportation package, and this was one of them.
- Starting NOW to ensure we get this passed in the short session of 2026.

Legislative Update

HB 3518 – A&T Funding

- We were close, but in the end, we had several associations speak up in opposition that killed our bill. The largest opposition was Special Districts and LOC. They are looking for additional modifications including:
 - County Need allocation mechanism
 - Performance benchmarks
 - Creating protections or waivers for low-capacity taxing districts
 - Require approval for financial and operational plans before distribution of additional funds
- We will spend the interim to better understand our stakeholder's opposition and need.
- Special Districts believes it's a Core County Function

Legislative Update

HB 3940 – Fire Districts/Fire Patrol

- Increases dual protection from 5 acres to 10, and now includes bare land. Heavy workload the first year (2026), but easy to administer from that point forward.
 - In light of A&T funding, this could be used to gain support from our Fire Chiefs.
