5. THE WALL THAT HEALS

Billy Whisenant, co-chair The Wall That Heals Committee, was present today to talk to the Board about The Wall That Heals that will be on display in Independence Oregon from September 18-21, 2025. Mr. Whisenant stated that the last time he was present, it was to request funding assistance from Polk County and he wanted to thank them for granting them \$12,000.00 in funds to cover the site fee. This was to help bring The Wall That Heals to Polk County. Mr. Whisenant stated that 140 cities applied to bring the wall to them and that the City of Independence was 1 in 30 that was approved, and they are very proud of that. He also talked about some other sponsorship they have received from the community. Mr. Whisanant stated that they still need more volunteers and are about halfway to their goal for the number of people they need. Next, he talked about the dates that they will be here and what kind of activities and ceremonies will be taking place. Mr. Whisenant introduced John McArdle and asked him to talk about anything that he may have missed. Mr. McArdle talked about their committee of 21 people and stated that they have worked really well together and how it is like a well-oiled machine, which they are very proud of. Mr. McArdle talked about why they wanted this to happen in September and the importance of sharing this history with our youth. Mr. McArdle asked the Board to please help get the word out and he would love to see each of them there. Mr. Whisenant stated that they have multiple Vietnam Veterans on their committee and then went on to share a personal story about his time in Vietnam and another soldier who died in combat and his name is on the wall. He talked about some coins they had made with his name on them and how they are making sure to get some to his family. Mr. Whisenant said they were very grateful and he wanted to make sure people understand how healing it is for him and other vets to see The Wall That Heals. Commissioner Mordhorst said he would love to help connect them with some individuals who could potentially volunteer. Brent DeMoe, Family and Community Outreach Director, stated that he wanted to make sure that they shared

how to get in contact with them. Mr. Whisenant talked about the local businesses that have donated items and what has been donated. He stated that Mr. DeMoe and his team have been invaluable to this project as well. Mr. DeMoe stated that this will be located in Independence Sports Park and talked about how they plan to help assist them in this. Commissioner Pope asked how the social media management is being done and Mr. McArdle answered his question. Mr. Whisenant stated they he has also made a FaceBook page for this and talked about the other ways they are planning to get the word out; they just don't want to do it too early. Mr. DeMoe asked about us displaying a banner to help get the word out in Dallas and the Board thinks the best location for the banner would be at the Academy Building.
