RE: Support for Rural Health Transformation Funding – West Valley Hospital Expansion

Dear Governor Kotek and Dr. Hathi,

We are writing to express our strong support for Salem Health's proposal to expand and modernize West Valley Hospital in Dallas, Oregon. This project is a critical investment in rural healthcare infrastructure and directly aligns with the State of Oregon's goals to improve access, equity, and outcomes for underserved populations.

Polk County is one of the fastest-growing regions in Oregon, driven in part by local efforts to increase affordable housing and attract working families and retirees. Between 2020 and 2022, the county's population grew by nearly 19%, with the senior population increasing by over 50%.
