7. RATIFICATION OF FOPPO LABOR AGREEMENT (2011-2014)

Greg Hansen, Administrative Officer, explained the 3 year contract with the Federation of Parole and Probation Officers (FOPPO), which covers approximately 10 county employees. This contract includes a 3.5% salary range increase, one additional floating holiday, bilingual pay increase to 5%, the health insurance opt-out stipend was increased to \$250 monthly, and there was a uniform and equipment provision that will provide polo shirts, field pants, jackets (with Velcro name tag attachment), flashlights and shoulder microphones, and ear pieces. One additional Parole and Probation Officer III position will also be created.
