### 7. PUBLIC HEARING – LEGISLATIVE AMENDMENT LA 11-02

Jerry Sorte, Planning Manager, explained that the purpose of this public hearing is for the Board of Commissioners to receive public testimony and to consider changes to Polk County Zoning Ordinance Chapters 112, 128.500, 128.700, and 128.800. The proposed updates will reduce the setbacks for fences and signs, and would remove specific restrictions on the size, number, and allowed uses of garages. The amendments would also update the standards for hardship dwellings and would amend the height restrictions for accessory structures in certain zones.

The Planning Commission held a public hearing on October 18, 2011 and unanimously recommended that the Board adopt the proposed amendments. However, staff recommended continuing the public hearing until February 1, 2011 to allow the cities and the public more time for comments.

Chairman Pope opened the meeting for public testimony and asked if there was any testimony from the public.

Tom Hall of 1574 37<sup>th</sup> Ave. NW, Salem, OR 97304 testified that he is outside of the City of Salem city limits, but within the Urban Growth Boundary. Mr. Hall testified that he wants to build a tree house, but because he will need a support beam from the ground, the tree house is considered an accessory structure. In order to build it, he would need to get a waiver from the City of Salem to have an accessory structure above 15 feet, but the City told him that they have no policy allowing them to waive the height limitation. Mr. Hall is in favor of these amendments, but requested that the Board not continue the hearing until February but instead adopt the amendments today.

Jason Locke, Community Development Director for the City of Dallas testified that the City also finds this issue problematic and supports the establishment for a height limit for accessory structures to streamline the process. The City of Dallas has review authority through the Urban Growth Boundary management agreement.

MOTION: COMMISSIONER WHEELER MOVED, COMMISSIONER AINSWORTH SECONDED, TO APPROVE STAFF RECOMMENDATIONS TO CONTINUE THE PUBLIC HEARING UNTIL FEBRUARY 1, 2012.

MOTION PASSED UNANIMOUSLY.

Commissioner Pope announced that the public hearing would be continued until February 1, 2012.

Approved contract #11-203, Personal Service Contract between Polk County and Bradley Houck to provide mental health/counseling treatment.
