# 7. PUBLIC HEARING – COMPREHENSIVE PLAN AMENDMENT & ZONE CHANGE

Jerry Sorte, Planning Manager presented the staff report. The Pedee Cemetery Maintenance District has submitted two applications, comprehensive plan amendment PA 11-02 and zone change ZC 11-03, for the property located one property north of 12970 S Kings Valley Hwy, Monmouth, Oregon. The Womer cemetery is currently located on the northern half of the 4-acre property, and the purpose of these applications is to expand the cemetery to the southern half of the property. The applicant is proposing to change the comprehensive plan amendment designation of 2.16 acres from agriculture to public, and change the zoning of the area from exclusive farm use to public and private cemeteries, with a limited use overlay, which would restrict the area to cemetery-only (required to address the "Reasons Exception" criteria).

There was a public hearing held on these applications on April 10, 2012, at which time the hearing's officer recommended approval. The staff also recommends the Board approve these applications.

Commissioner Wheeler opened the public hearing and asked if anyone wished to testify.

Lane Shetterly, legal representative for the Pedee Cemetery District said that the notice of "Goal Exception" will still have to be approved through the Department of Land Conservation and Development. Mr. Shetterly estimates that this expansion will allow the cemetery the space to continue operating for the next 40 years.

Commissioner Wheeler asked if there was anyone else who would like to testify. Hearing none, the public hearing was closed.
