7. PUBLIC HEARING - ORDINANCE 12-04

Chairman Ainsworth opened the public hearing.

David Doyle, County Counsel presented Ordinance 12-04 in the matter of enacting amendments to Chapter 42 of the Polk County Code of Ordinances. Doyle explained that currently, the only options deputies have are to issue warnings or a criminal citation for livestock at large. This Ordinance would add a code enforcement option for civil sanction which can be cited to either the Dog Board or Circuit Court. If the Dog Board issues a fine, the County would collect it; but if it is not paid, the order would have to be turned into a Circuit Court judgment for enforcement powers.

Jim Clawson, President of the Polk County Livestock Association testified in support of the amendment. However, he expressed concern that the proposed amendment is not clear where the Dog Board would fit in and what the process for the citation would be. The Livestock Association would like to clarify what 'adequate fencing' is, as referenced in the amendment.

Ray Steele with the Polk County Farm Bureau testified that the amendment should include the State Statute (ORS 607-700) regarding 'adequate fencing'. Mr. Steele explained that currently, the Oregon Department of Agriculture is the only entity that can determine what is an adequate fence for cattle and horses, and who is responsible for paying for that inspection. The Board was concerned that most of the livestock that gets out are not cattle and livestock, and 'adequate fencing' is different for each type of animal.

Paul Johnson with the Dog Board and the Livestock Association also testified that 'adequate fencing' should be more clearly defined.

Austin McGuigan, Community Development Director cautioned the Board that the more defined 'adequate fencing' is in the Ordinance, the more burden that puts on the landowners to prove that a fence is adequate. David Doyle recommends that the Dog Board be the one to determine adequate fencing, and if a landowner does not agree with the determination, then the landowner could pay for an inspection by the Oregon Department of Agriculture, and if the finding were different from the Dog Board's finding, then the fine would be removed.

Chairman Ainsworth asked if anyone else wished to testify. Hearing none, he recessed the public hearing until September 12, 2012.

At 9:44 a.m., Chairman Ainsworth asked if there was need for an Executive Session. Staff answered that there was not and the meeting was adjourned.
