#### a. TRIBAL TRUST LAND REQUEST

Greg Hansen, Administrative Officer presented three notices from the Department of the Interior inviting public comment regarding parcels of land that the Confederated Tribes of Grand Ronde are requesting to be put into trust. The total amount of taxes associated with these tax lots is approximately \$714. In the past the Board has responded with a generic letter expressing concern of any land being taken off the County's tax base. The Board directed Greg to send the same letter that has been used in the past to respond to these three notices.
