A member of the public raised the issue that the Board did not have an ordinance recognizing Free Speech Law, so the proposed amendment to section 17.700 clarifies that the County follows the law. Chairman Ainsworth asked if anyone wished to testify. Hearing none, he closed the public hearing.
