7. FAIRGROUNDS PARK & RIDE DISCUSSION

Todd Whitaker, Public Works Director was contacted on Monday by Salem-Keizer Area Transportation (Cherriots), claiming that the County is not in compliance with the Intergovernmental Agreement for the Fairgrounds Park & Ride because there are signs posted that identify the Park & Ride for the bus stop, and direct carpoolers to the other park & ride facility that is further north off Hwy 99. The County was directed to remove the signs by November 26, or else the County will be ineligible to receive future ODOT funding. Dave Doyle, County Counsel has reviewed the contract and explained that the 'Park & Ride' definition is not included, even though the Park & Ride was designed for a bus stop, for those customers parking and riding the bus.

Ray Steele, Polk County Fair Board would like to meet with Cherriots at a later date to discuss building a fence to separate the Park & Ride area from the Fairgrounds parking area.

The Commissioners directed staff to remove the signs.

At 9:45 a.m., County Counsel announced that the meeting was recessed to Executive Session to consider the dismissal or disciplining of, or to hear complaints or charges brought against, a public officer, employee, staff member or individual agent, unless such public officer, employee, staff member, or individual agent requests an open hearing pursuant to ORS 192.660(2)(b). Although the public will be excluded, no vote may be taken in executive session. Media may attend but may not report on the meeting. A CD of the meeting is on file in the Board's office, but is confidential under ORS 192.660.

Chairman Ainsworth called the meeting back into regular session at 10:29 a.m. and the meeting was adjourned.
