PUBLIC HEARING - COMPREHENSIVE PLAN AMENDMENT AND ZONE CHANGE

Chair Wheeler opened the public hearing. Jerry Sorte, Planning Manager presented the staff report. The application requests a Comprehensive Plan amendment from agriculture designation to Farm/Forest and Zoning map amendment from Exclusive Farm Use (EFU) to Farm/Forest Overlay for the 1,273 acre tract. The applicant has received a conditional use permit contingent upon this land use change to operate a sawmill on the property. On November 27, 2012, a public hearing was held and the Hearings Officer's recommendation was to approve the application.

Chair Wheeler asked if anyone wished to testify. Ben Deumling of 4550 Oak Grove Rd, Rickreall, OR 97371, Zena Forest LLC representative was on hand to answer questions. There was no other testimonies. Chair Wheeler closed the public hearing.

MOTION: COMMISSIONER POPE MOVED, COMMISSIONER AINSWORTH SECONDED, TO ADOPT COMPREHENSIVE PLAN AMENDMENT PA 11-01 AND ZONE CHANGE

ZC 11-02 AS PRESENTED.

Staff will prepare a Board Ordinance for this comprehensive plan amendment and zone change for adoption on the consent calendar on January 23, 2013.

7. PUBLIC HEARING - LEGISLATIVE AMENDMENT

Chair Wheeler opened the public hearing. Jerry Sorte, Planning Manager explained that the purpose of this public hearing is for the Board of Commissioners to receive public testimony and to consider changes to Polk County Zoning Ordinance Chapter 136 (Exclusive Farm Use Zone), Chapter 138 (Farm/Forest and Farm/Forest overlay Zones), and Chapter 177 (Timber Conservation Zone). The proposed updates will allow for greater economic opportunities within the above resource zones, while maintaining strong protection of resource land and protections for neighboring farms and forest operations that are the trademarks of Oregon Statewide Planning Goals 3 and 4. The Planning Commission held a public hearing on October 23, 2012 and recommended that the Board adopt the proposed amendments.

Jerry explained that these proposed changes would create a "safe harbor" to allow food service as a commercial activity in conjunction with farm use on land zoned for exclusive farm use (EFU) and farm forest use (F/F). The proposed "safe harbor" allows for a 500 square foot restaurant on farm lands as long as products from the farm are featured in the menu items.

Chair Wheeler opened the hearing for public testimony and asked if there was any testimony from the public. The Friends of Polk County submitted a letter from the 1000 Friends of Oregon, supporting the proposed amendments, but requested the Board wait on moving forward on the amendments until the Yamhil County vs. Friends of Yamhill County case is decided on through the Court of Appeals, scheduled for March 19, 2013.

MOTION: COMMISSIONER POPE MOVED, COMMISSIONER AINSWORTH SECONDED, TO CONTINUE THE PUBLIC HEARING UNTIL APRIL 10th, 2013.
