# 7. PUBLIC HEARING - LEGISLATIVE AMENDMENT (Continued from January 9, 2013)

Jerry Sorte, Planning Manager explained that this hearing is a continuation from January 9, 2013. At that hearing, the '1000 Friends of Oregon' requested the Board delay the adoption of LA 12-01 pending the decision of the Court of Appeals on a Yamhill County case which may have affected the regulations of the proposed Food Service Safe Harbor. The Court of Appeals issued its decision on March 19, and affirmed the Land Use Board of Appeals decision. Staff concludes that the amendments proposed in LA 12-01 comply with all applicable Polk County review and decision criteria, state statutes, administrative rules, and case law interpretation, and staff is recommending the Commissioners adopt the amendments as proposed.

Chair Wheeler re-opened the hearing for public testimony and asked if there was any testimony from the public. Hearing none, the public hearing was closed.
