#### 7. COLUMBIA COUNTY IGA

Greg Hansen presented an IGA with Columbia County for the rental of jail beds. Columbia County is awaiting the results of a bond measure to keep their jail open. If the bond passes, this agreement would be void. If the bond fails, Polk County would start housing Columbia County inmates starting June 1, 2014. The agreement is for ten permanent beds at a rate of \$65 per day, with an option to add two additional beds at a rate of \$75 per day. The potential fiscal impact for Polk County is approximately \$250,000 increased revenue. Columbia County would be responsible for transportation to and from the facility, and medical costs associated with their inmates.
