7. RESOLUTION 14-11 – PUBLIC SAFETY LOCAL OPTION TAX (OPERATING LEVY)

Greg Hansen presented a memo and Resolution 14-11 in the matter of calling for a public hearing on the decision to submit to the voters the question of approving a public safety operating levy in an amount not to exceed \$0.45/\$1,000 of assessed value. Greg explained due to reduced timber revenues in the General Fund, public safety programs have been severely reduced. In order to combat the eroding services, Greg is recommending the Board pursue an operating levy focused on Public Safety programs. Greg proposes a levy in the amount of \$0.45/\$1,000, which would generate approximately \$2.3 million annually and allow for the County to hire approximately 22 public safety FTE, and rent an additional two juvenile detention beds.

Sheriff Wolfe and District Attorney Aaron Felton both expressed their appreciation for the Board to move forward with starting the public input process, and feel it is the rights step for the County, but both also expressed concern with the timeline, once the public hearing process is over, to develop an effective campaign before the May 19, 2015 elections.

MOTION: COMMISSIONER WHEELER MOVED, COMMISSIONER POPE SECONDED TO ADOPT RESOLUTION 14-11 IN THE MATTER OF CALLING FOR A PUBLIC HEARING ON THE DECISION TO SUBMIT TO THE VOTERS THE QUESTION OF APPROVING A PUBLIC SAFETY OPERATING LEVY IN AN AMOUNT NOT TO EXCEED \$0.45/\$1,000 OF ASSESSED VALUE.

MOTION PASSED BY A UNANIMOUS VOTE OF THE QUORUM.
