SUBJECT: SUPPLEMENTAL BUDGET 2014-2015

RECOMMENDATION:

The Board approve the Supplemental Budget Resolution 15-07 to increase revenues and appropriations within the Health Services Fund (Family & Community Outreach) for fiscal year 2014-2015.

ISSUE:

Should the Board approve a supplemental budget resolution for fiscal year 2014-2015?

BACKGROUND:

During fiscal year 2014-2015 budget year, the Health Services Fund will have expenditures and revenues beyond what was anticipated when the budget was adopted based upon accounting practices.

The Family & Community Outreach program of the Health Services Fund will be recieving additional revenues and have expenditures as a result of the construction/remodel and operations of the School Based Health Clinic located adjacent to Central High School. There are multiple sources of revenues to cover the project expenses that total an additional \$500,000 to the budget.

This project was not anticipated/confirmed when the 2014-15 budget was adopted.

ALTERNATIVES:

The following are alternatives:

- 1. Approve the recommendation as proposed. Allows the County to meet all of the budgetary requirements and laws.
- 2. Modify the recommendation to increase or decrease the amount of the supplemental budget.
- 3. Not approve a supplemental budget and end up violating Oregon budget law.

FISCAL IMPACT:

The increase in revenues and appropriations for the Health Services Fund – Family & Community Outreach is \$500,000.
